#### Tom's strongest areas are:

- TS3 Excellent subject knowledge demonstrated in clear explanations across KS3 and 4, this was evident in the year 7 observation on the respiratory system and the year 10 observation on telescopes. Tom's clear explanations supported students to fully grasp the content covered.
- TS6 Book scrutiny demonstrated that the school assessment policy is being rigorously followed with all classes, for example year 9 books were marked and students made clear improvements to their work in green pen.
- TS7 The warm welcome pupils always receive when entering the classroom provides a positive start to lessons and has encouraged strong relationships; this is a particular strength with year 8. There is a very positive and supportive learning atmosphere in each lesson.

I have thoroughly enjoyed my first term as an ECT and I believe I have made good progress towards the Teachers' Standards. I agree with the report written by my induction tutor and I have found her feedback and discussions very useful.

I have found my behaviour management (TS7) a strength in comparison to my training year, as I have been able to set high standards of behaviour with all my classes using praise to create a positive learning environment with all my classes. I agree with my target to work on responding to the needs of more able students (TS5), particularly with year 8 and plan to use some of my free lessons to observe experienced teachers this term. I will try and incorporate live modelling to demonstrate the standard of work they are aiming for, but ensure I plan and get these models checked by my mentor in advance.

Moving forward I feel that I do have gaps in my subject knowledge (TS3) for A-Level so I would like to get in to observe some lessons. I'd like to identify a few areas of weakness and work with David to improve my subject knowledge in these areas as I feel it will increase my confidence in other areas.

I have really enjoyed my first term at Bexley High and the staff in the department have been incredibly supportive and welcoming. The aspect I enjoy most is the focus on discussing teaching and learning and I look forward to next term.
